Our Experience

Transport Infrastructure

We act for clients on infrastructure projects in Scotland and throughout the world, including rail, metro and tram projects. Our work involves station redevelopments, track construction and rolling stock. Recent experience includes procurement advice on a US\$1 billion European rail electrification project. We have also acted for clients on a number of long span bridge projects throughout the world, including in Scotland and elsewhere in the UK.

Offshore Wind

We have advised on offshore wind projects around the world, including 70% of the wind farms off the shores of the UK. We advise on contract negotiation and disputes. We have recently acted on disputes in relation to the world's largest offshore wind project in the North Sea, and separately, on an innovative offshore windfarm in Scottish waters, built to trial next generation technology.

Civil and Structural Engineering

We have been instructed on a number of high profile civil and structural engineering projects in Scotland. We have acted on an £8m dispute in the Court of Session regarding claimed defects at a major medical facility in Scotland. We have also advised on cladding issues affecting various Scottish social housing developments. We have extensive experience - in Scotland and around the world - on tunnelling projects, including groundworks, geotechnical issues, ground conditions and TBM procurement. We have also negotiated and drafted EPC Contracts and specialist civils subcontracts for various energy from waste projects.

Heavy Engineering

Our team has in-depth knowledge and strong experience of high value and technically complex heavy engineering and infrastructure projects around the world. Recent experience in Scotland includes advising on EPC contracts for ports and terminals projects and energy from waste facilities.

Renewables

In addition to offshore wind, we are well versed in renewables projects, such as hydro. We recently acted for a major contractor on one of the largest and most technically complex disputes before the Scottish Courts, regarding collapse of part of a tunnel at a hydroelectric plant in Scotland. Other recent instructions include advising on the EPC contracts for PV plants, and drafting and advising on contractual documentation for development and roll out of lead crystal battery storage technology.

Sub-sea Cables

We have significant experience of sub-sea cable contracts, including major interconnector projects. Our experience means we have valuable insights into the risks involved with the sub-sea cable projects and how best to manage those risks in the contracts. Recent experience includes advising on a cable package for a major offshore wind farm in Scottish waters.

Marine Construction

HFW's sectoral expertise in Construction and Shipping means we are ideally placed to advise on marine construction projects. We recently advised on the EPC Contract for harbour expansion works at a major Scottish port. Other instructions concern delay and defects claims before a dispute adjudication board; advising on termination of a contract at a major international port; and providing legal advice, project support and drafting remedial works contracts following damage to a terminal from a vessel collision.

Oil and Gas and **Decommissioning Projects**

We act on offshore oil and gas projects across the globe. We have drafted decommissioning contracts, and have acted on disputes on decommissioning projects. We have recently advised on £15m claims arising from the decommissioning of 10 offshore oil & gas jackets and topside structures at an oil field in Scottish waters.
